I understand that if awarded a tuition scholarship:

- I will be notified of the scholarship amount before my first tuition payment is due on September 15, 2007.
- I will pay the balance due on September 15, 2007 and January 15, 2008, in equal amounts. If paying the balance due in two installments still represents a financial hardship after subtracting the scholarship amount, it is my responsibility to contact the Executive Director to work out a payment plan to which I will be able to commit.
- My child and I will be expected to volunteer a total of ten (10) hours of service to Commonwealth Youthchoirs, Inc. during the 2007/2008 season. This will be coordinated with the Membership Coordinator before the scholarship is applied to any tuition due. At least five (5) volunteer hours need to occur before the Holiday Concert in December
- My child will attend all rehearsals and concerts (and will arrive on time) unless (s)he has received a pre-approved absence from the music director.
